

BILTIR celebrates 10 years of supporting Bermuda's long-term insurance and reinsurance industry

HAMILTON, Bermuda, 17 June, 2021 – Bermuda International Long Term Insurers and Reinsurers (BILTIR) is celebrating 10 years of successfully supporting the island's long-term insurance and reinsurance sectors, which provide life and annuity products.

BILTIR was set up in June 2011 to act as an advocate for Bermuda's long-term sector industry. It's first initiative was to collaborate with the Bermuda Monetary Authority (BMA) to help Bermuda with its push to achieve Solvency II equivalence with the European Union. The association actively represents Bermuda's life and annuity industry, through public policy discussions, providing feedback on regulatory requirements and working with the BMA and Bermuda government on issues affecting the island's long-term sector.

BILTIR started with five member companies - Athene Life Re, Transamerica Life Re, Aurigen Re, Front Street Re, and Wilton Re Bermuda.

Today, BILTIR represents 61 long-term insurance, reinsurance and servicing companies which employ more than 600 people on the island, of whom 60% are Bermudian. Advocacy is carried out by four committees covering tax, regulatory/legal, capital and financial reporting.

In 2011 when BILTIR was launched, assets under management (AUM) by the long-term sector were \$157 billion. In 2019, AUM in the sector had grown to \$544 billion, and the Bermuda Monetary Authority (BMA) estimates the figure will grow to approximately \$607 billion for 2020. BILTIR member companies manage the vast majority of these assets.

In the past 10 years, BILTIR has worked with the BMA on the Bermuda Capital Solvency regulations and contributed to BMA consultations on issues such as cybersecurity, anti-money laundering, and market conduct.

The Premier of Bermuda, the Hon. David Burt, JP, MP, said:

"On behalf of the Government and people of Bermuda, I congratulate BILTIR on its ten-year anniversary and for its continued growth over the past decade. The association has grown to include over 60 members employing more than 600 people, the majority of them Bermudian.

"We are grateful for BILTIR's commitment to our island and its significant contributions to our economy, public education, and the third sector. We look forward to further collaborations and strengthening our positive relationship in the years to come."

Our growth is impressive, but the best is yet to come."
